

# Montgomery County Central Vendor Registration System Search Tools

Montgomery County maintains a vendor registration system that can be used by the public to identify companies that sell a variety of goods and services. Public entities in Montgomery County utilize this database to advertise opportunities and locate capable firms.

Local companies are encouraged to utilize this database not only to register as a vendor with several public entities in the county, but also as a business development tool. This searchable database can be used to locate potential partners, prospects and prime vendors business opportunities.
